- In all cases it begins with the end in mind

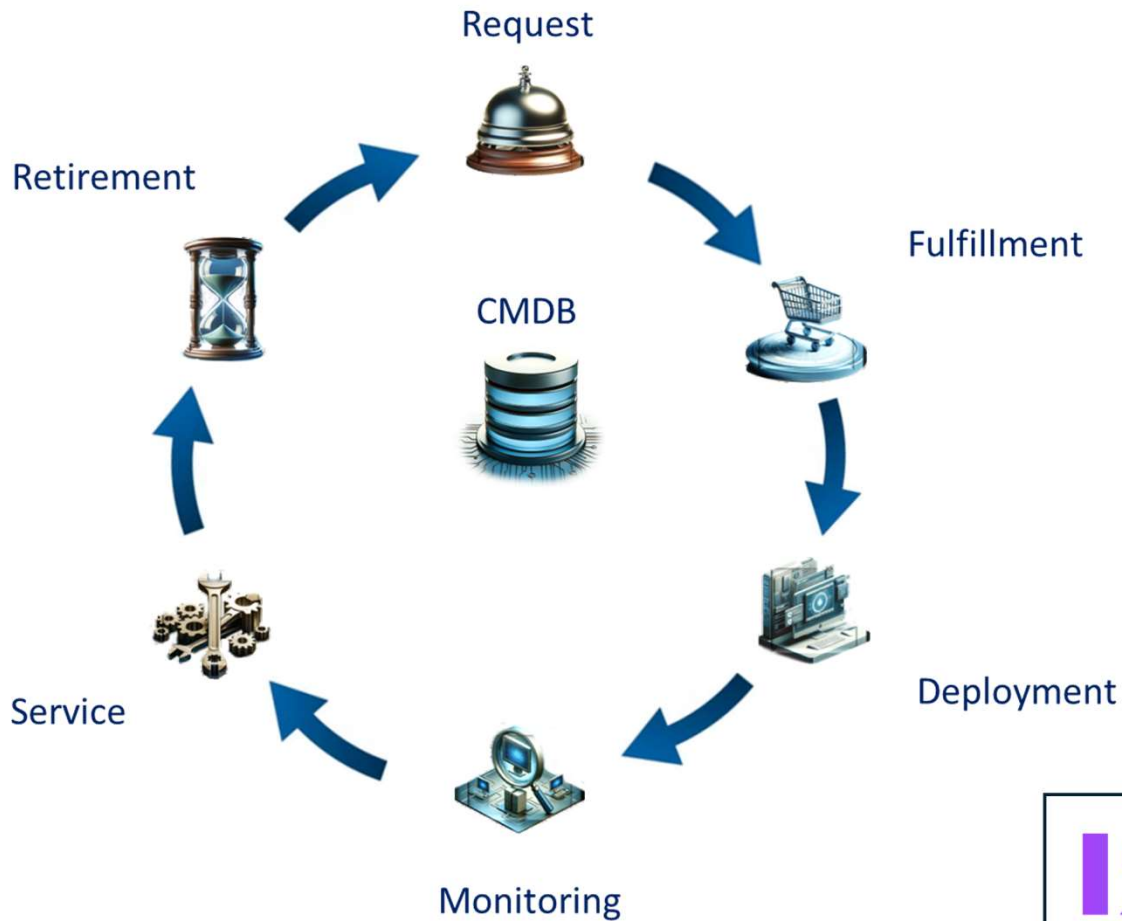

- Don't focus on what you don't have, focus on what you do have
- Remember, SAM is everyone's responsibility
- Include
 - IT and business leadership
 - Software and hardware infrastructure teams
 - Legal
 - Service Management

- What is your role in the organization? How is it related to SAM?
- Who else is involved in SAM?
- What are SAM goals and key performance indicators?
- How is success measured
- Focus areas
 - Data capture and repository
 - Software and hardware inventory
 - Position reporting
 - Technology Acquisition
 - Governance

Building and testing ELPs may be your next step

- Start by identifying the vendors who make up 80% of your software costs
- Identify at-risk vendors
- For these vendors
 - Document entitlement
 - Identify available tools to track deployment
- Report and address compliance regularly



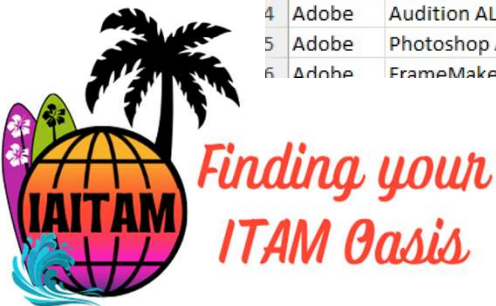

Effective License Positions

- The approach can be simple
- ELP = Entitlement – Deployment
 - Positive is good
 - Negative needs to be addresses
- Don't let perfect get in the way of good
 - A spreadsheet will do just fine

Next Best Step 3

If you are unclear on your response to an Audit Letter...

An Audit Response Team may be your next step

- A sitting team tasked with coordinating and responding to audit requests ensures that letters don't fall through the cracks
- A sitting team is educated and knows the words to use and steps to take
- When not in an audit, team can test ELPs, and support software procurements as needed

Make-up of an Audit Response Team

- Team lead should be responsible for SAM and in a full time SAM role
- Team should include a cross-section of business and IT
 - IT leadership
 - Procurement for contract knowledge
 - Software and hardware infrastructure teams
 - Legal

Next Best Step 4

If you have a tool in place
and are still struggling...

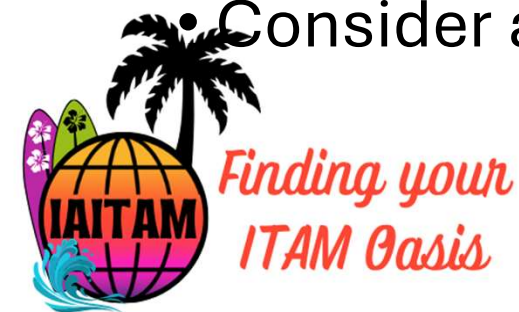

A Refocus of your effort to utilize the tool

- Ensure that the included CMDB is your single source of truth
- Ensure that purchased software (entitlement) is loaded into the tool
- Ensure that all sources of deployment data are loaded into the tool
- Include all platforms – Desktop, Server, Mainframe – but start small
- Consider a pilot to restart your project

Questions to Consider

- Is the tool part of a larger architecture? Is part of the tool working?
- Did you or would you consider a pilot of a single vendor?
- What are your goals?
 - Compliance
 - Procurement support
 - Service management support
- When automating, what is the goal?
 - Ensure that all components are loaded before testing or embarking on automation

Market Research in Procurement may be your next step

- Build product requirements
- Utilize RFI/RFP processes
- Review alternatives
- Benchmark deals with reputable data sources
 - Not your reseller
 - Not your vendor
 - Not your auditor

Market Research

- Complete for every new and renewed contract
- Ensure leadership buy in to the process
- Review requirements
- Establish and review alternatives
- Ensure vendors understand your process
 - You can argue with people, you can't argue with a process
- Consistently measure success

SAM Awareness training may be your next step

- When you assess your program...
 - Ask your executives what they think of SAM
 - Ask staff what SAM means
- Do you have a policy for SAM?
- Is SAM in your HR manual?
- Are staff required to sign-off on SAM training
- The goal should be for the CIO to ask about SAM regularly

SAM Awareness

- New employee orientation
- Annual training review and sign-off
- More extensive training for systems administrators
- All SAM practitioners should be certified
 - CSAM
 - ITIL Foundations

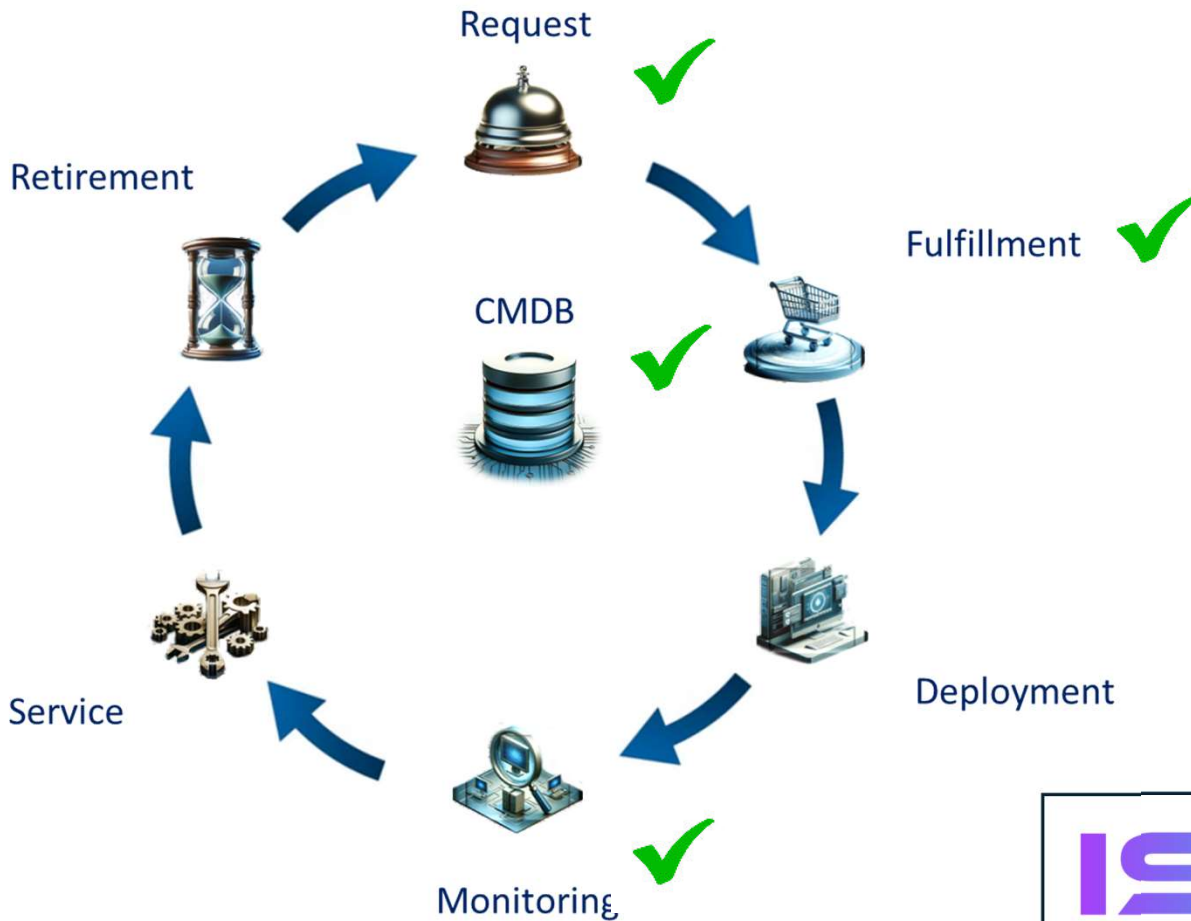

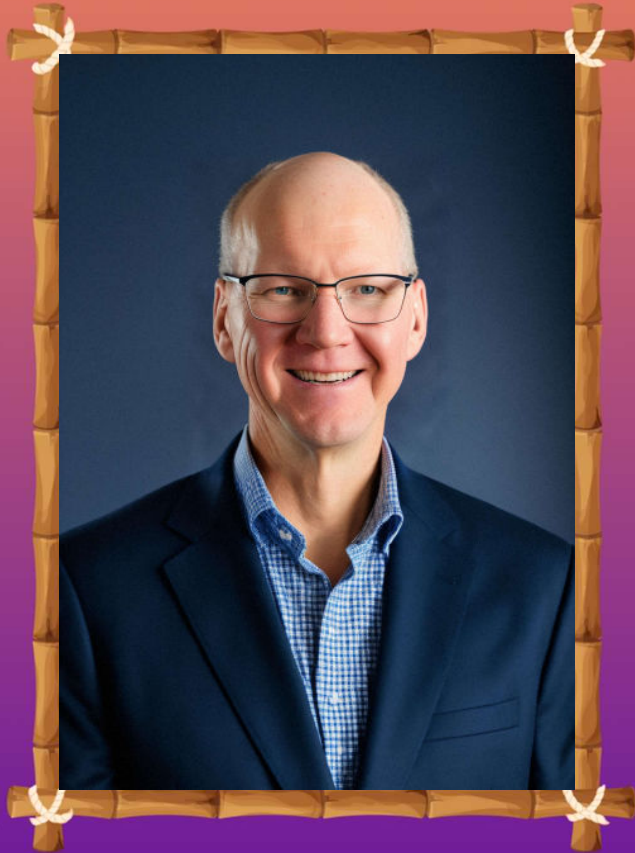
Conclusion
