### Java Compliance Overview

- Since Oracle adopted the Employee metric for Java licensing in January 2023, Java compliance has become an all or nothing position for customers.
  - An employee or server with licensable Java can cause the entire employee population to be licensable for Java.
- Customers needing to maintain Java compliance fall into 2 categories:
  - Have an existing subscription under the legacy Processor and Named User Plus metrics.
    - Maintain the Java footprint covered by the subscription at the same level or below.
  - Oracle allows subscribers on the legacy metrics to retain them if they do not exceed their subscription quantities, subject to confirmation.
  - If they report being over deployed, Oracle will require them to relicense under the Employee metric.
- Have no existing Java subscription.
  - Avoid deploying licensable Java.

Licensable Java Criteria

- Currently licensable Java is outlined in the Oracle Technology Network Agreement for Oracle Java SE (OTN).
- Licensable Java:
  - Commercial (production) usage
  - Versions from 8.0.211 on, with the exception of Long-Term-Support (LTS) releases licensed under the No-Fee Terms and Conditions (NFTC) license:
    - Versions of 17 released through September 2024
    - Current versions of 21
  - Some Oracle products (e.g. WebLogic, E-Business Suite, OCI) and 3<sup>rd</sup> party applications cover Java licensing.

Strategies for Maintaining Java Compliance

- Deploy OpenJDK or non-Oracle Java builds as an alternative to Oracle Java.
- Block Java downloads and installations.
- Prepare internal communications and staff
  - Ensure that staff is fully informed about the implications of Oracle Java licensing.
  - Develop prepared internal communications and provide training to IT support team members.
- Strict licensing verification
  - Ensure that Java is only allowed on systems where Oracle or third-party licensing covers the Java licensing.
- Implement periodic checks for Java compliance.
- Establish a response plan for Oracle Java audits.
- Implement procurement procedures to ensure that new 3<sup>rd</sup> party applications are properly vetted for any Java dependency to maintain compliance.
