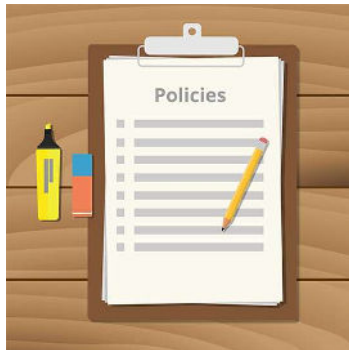

# Example Policies - Federal

## Agency Software Strategies – Centralizing and Improving Software Management

FITARA provides new authorities and responsibilities that CIOs can use to improve their agencies' IT management policies and practices. To improve covered agencies' software management practices, CIOs, in coordination with CAOs and CFOs, [must]:

- [Appoint] a software manager that is responsible for managing, through policy and procedure, all agency-wide commercial and COTS software agreements and licenses. The software manager shall report to the agency CIO and will work in collaboration with the offices of the CIO, CAO, CFO, and other organizations as appropriate.
- Maintain a continual agency-wide inventory of software licenses, including all licenses purchased, deployed, and in use, as well as spending on subscription services (to include provisional (i.e., cloud) software as a service agreement (SaaS)).
- Analyze inventory data to ensure compliance with software license agreements, consolidate redundant applications, and identify other cost-saving opportunities.<sup>86</sup>

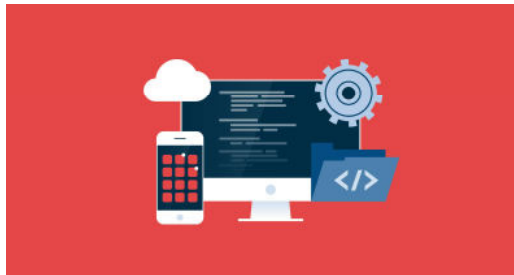

# Example Policies – State

The Department is required to establish and maintain an inventory of all information assets, including information systems, information system components, software, and information repositories both electronic and paper. The inventory shall contain a listing of all programs and information systems identified as processing, storing, or transmitting State information.

This Policy establishes requirements for maintaining an inventory of and effectively managing all software assets and licensing requirements.

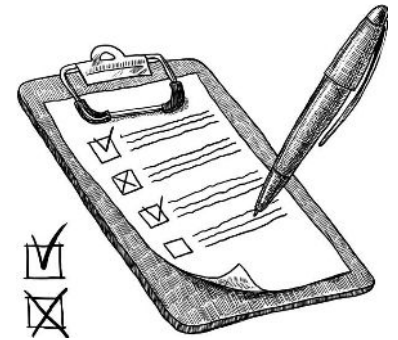
# Example Policies – State

The State prohibits the use of unlicensed software.

State employees are required to comply with copyright and license agreements. Computer software sold for use on State computers is copyright-protected, and State employees are to comply with the license agreements that accompany the proprietary software they use.

The State will:

- Conduct a 100% inventory of its software.
- Detect and remove illegal and unlicensed software.

Employees are not permitted to place any electronic materials, files or software on any organizational computing device without prior written approval.

- Goal 1
  - Required SAM policies are effectively implemented

    - Uniform
    - Clear evidence

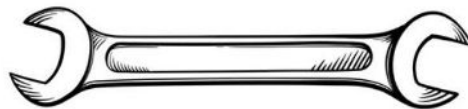

# Awareness is the Key – Procurement Executive

- What does SAM mean?

I would view it as a holistic approach to obtaining and managing the software tools that we rely on for our organization to run in the most efficient/cost effective way possible.

- How is success measured?

I think for cost there are comparisons (best in class, above average, etc.), but I'm not sure how that may take into account governmental requirements (i.e. certain purchasing programs, standard T's and C's, etc.). I am also assuming there are other comparative metrics available for organizations, such as the number of tools for given jobs, etc.

# Awareness is the Key – CIO

- What does SAM mean?

Software Asset Management is the tools and processes necessary for effective management, tracking, and control of our software assets through the entire lifecycle from procurement to retirement.

- How is success measured?

A KPI that is actionable including recommendations for improvements. Establishing baseline metrics so we can measure the effectiveness of our changes and improvements to the program.

# Executive Buy-in Leads to Staff Buy-in

- Before Buy-in
  - Chaos
  - Multiple tools performing the same function
  - PCard purchases
  - Departmental negotiations
- After Buy-in
  - Centralized acquisition
  - Review of redundant tools before acquiring another one
  - Industry benchmarks
  - Focused negotiations
