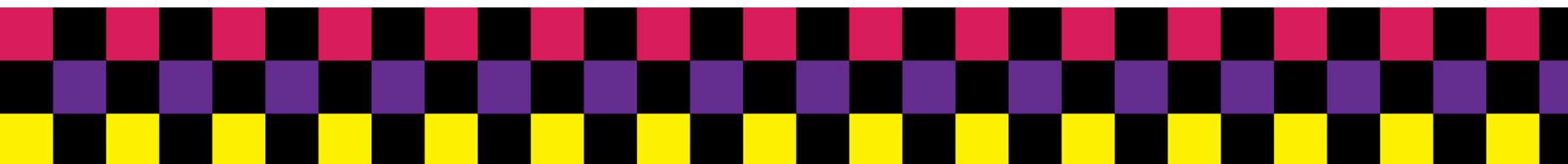

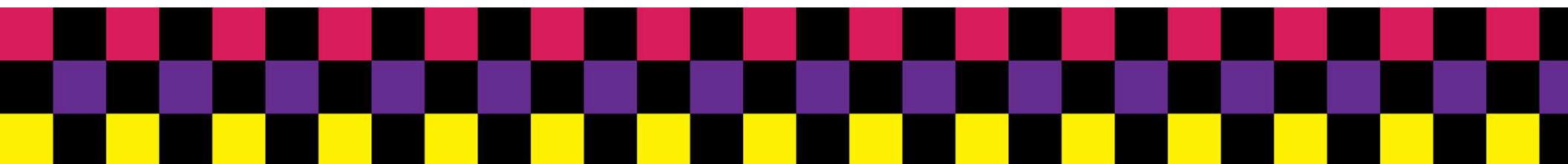

Transboundary Movement & Compliance Challenges - BASEL

1989

The Basel Convention on the Control of Transboundary Movements of Hazardous Wastes and Their Disposal was adopted.

1995

The Basel Ban Amendment was adopted, prohibiting the export of hazardous waste from developed to developing countries.

2011

The Cartagena Declaration on the Prevention, Minimization and Recovery of Hazardous Wastes and Other Wastes was adopted.

2022

Ghana and Switzerland amendments to the Basel Convention on the Control of Transboundary Movements of Hazardous Wastes and their Disposal approved.

1992

The Basel Convention entered into force, establishing a global framework for regulating the movement of hazardous wastes.

2006

The Mobile Phone Partnership Initiative (MPPI) was launched to promote the environmentally sound management of used and end-of-life mobile phones.

2019

The parties to the Basel Convention adopted new rules to control the global trade in plastic waste.

Transboundary Movement & Compliance Challenges

OTHER GLOBAL REGULATIONS AFFECTING ITAD

Discuss additional international laws and regulations that ITAD providers must navigate, such as the EU's WEEE Directive, China's ban on e-waste imports, and country-specific policies.

OVERCOMING REGULATORY HURDLES

Real-world examples of how ITAD companies have overcome compliance challenges, such as delays in asset shipments, penalties for non-conforming exports, and navigating complex documentation requirements.

TRADE WITH CHINA AND THE TARIFF SITUATION

The U.S.-China trade tensions have significantly impacted the ITAD industry, with tariffs affecting the cost and movement of refurbished electronics and e-waste exports. Compliance with changing tariff regulations is crucial to avoid unexpected costs and legal risks in international IT asset disposition.

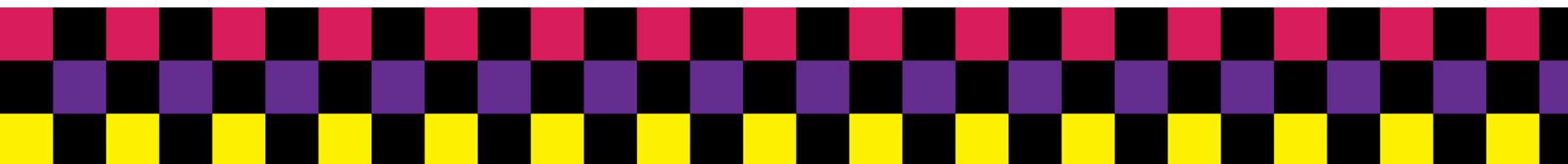
