Typical IT Ecosystem



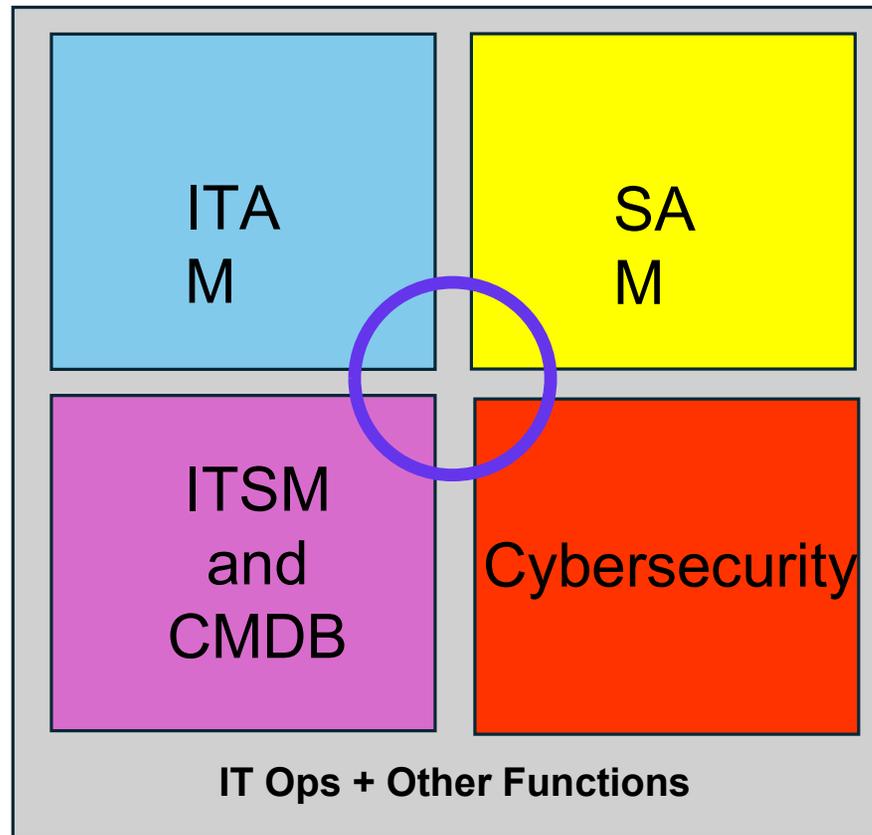
- Specialized tools

Foundational Data

- Discovery and Inventory
 - Network
 - Cross-platform endpoints
 - Cloud / SaaS
 - IoT and Edge
- Other Sources: Procurement, Contracts, HR, etc.
- Normalization
- Non-Discoverable Enrichment Data

Common Data Issues

- Data issues will diminish trust and confidence
 - Inconsistent naming
 - Inconsistent content and attributes
 - SAM data gaps
 - Operational data gaps
- Finding and compiling this data can be a huge effort

Inconsistent Naming

- Variations across systems and applications
 - Duplication of products and vendors
 - Manual cross-referencing to verify
- Results in inaccurate and incomplete reporting

Inconsistent Content

- From multiple data sources
- Data continuously added over time
- No common standards
- Inconsistent and incomplete data
 - Ineffective
 - Loses credibility with users

Product Enrichment Data

- Hardware and Software
- Manufacturer Product Codes
- Vendor and reseller codes and SKUs
- Categories and Classifications (e.g., UNSPSC)
- Licensing models, packages and use rights
- Hardware physical attributes, power usage, etc.

Product Enrichment Data

- Pricing data
- Vendor details
- Product Lifecycle Dates – EOL, EOS +
- Product versioning
- Vulnerability information – NIST, Maven, GitHub +
- Open source product attributes

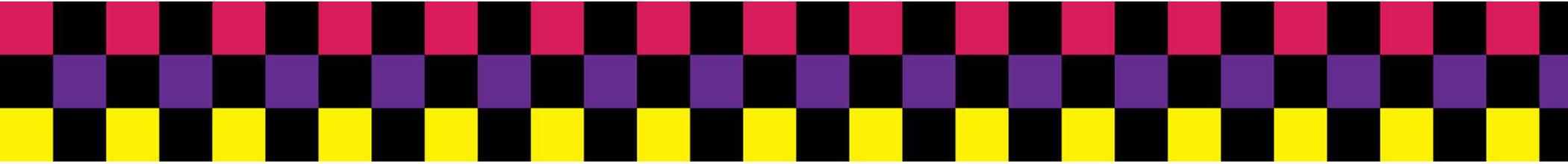
Usability

Creating and Updating Product Catalogs

- ITAM, SAM, ITSM, CMDB, Procurement catalogs
- Minimizes manual data searches
- Reduces time to create and update records
- Expands details for existing items
- Eliminates gaps and inconsistencies
- Stronger foundation for all processes

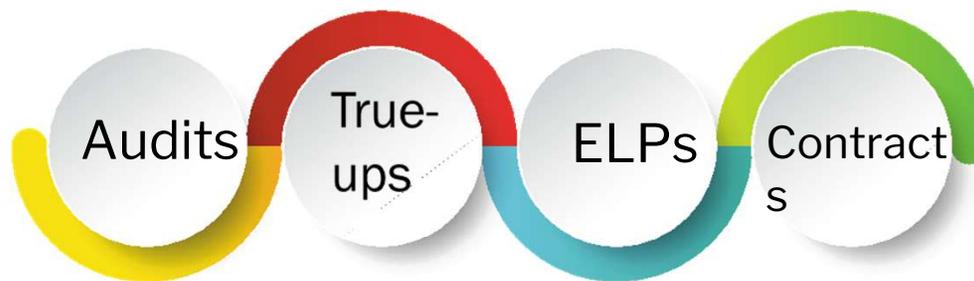

Enhanced SAM and ITAM Processes

- Higher quality data supports:
 - More effective, efficient processes
 - Expanded, more robust reporting content
 - Increased confidence in license position reports
 - More powerful workflows
 - Bigger savings potential

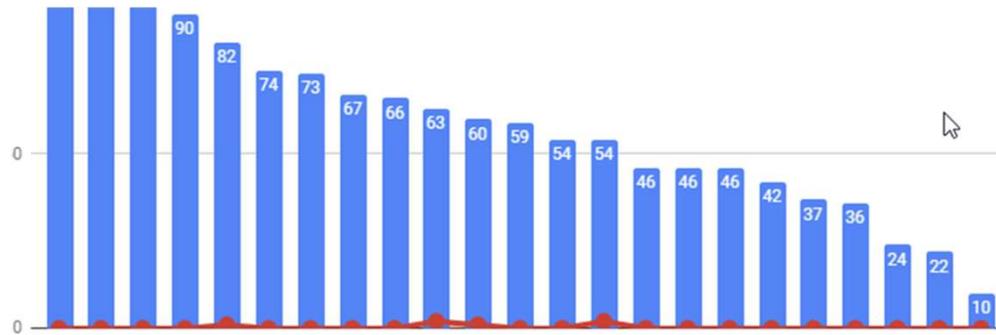

Streamlining Product Portfolios

- Identify redundant products with similar functionality
- Compare attributes to select best option
- Fewer products, vendors and agreements to manage
- Identify obsolete products and versions in use
- Reduce licensing costs and management effort

Managing Technical Debt

- Review products that make up infrastructure
- Visibility into age and obsolescence details
- End-of-Life and End-of-Support status
- Enable confident patching decisions
- Avoid unstable systems or unnecessary costs
- Buying the right equipment and software the first time closes the technical debt gap

Product Lifecycle Management

- Product lifecycle dates announced by vendors
 - GA, End of Support, End of Life and more
- Promotes proactive upgrade, refresh and patching plans
 - Helps avoid future compatibility issues
 - Reduces security risks due to inability to patch versions or products

Cybersecurity Support

- Product Lifecycle Dates
- Application Portfolio Streamlining
- Hardware and Software Vulnerability Data
 - Vulnerability identification and mitigation
 - Application and library/component level (SBOM analysis)
 - N-1 reporting

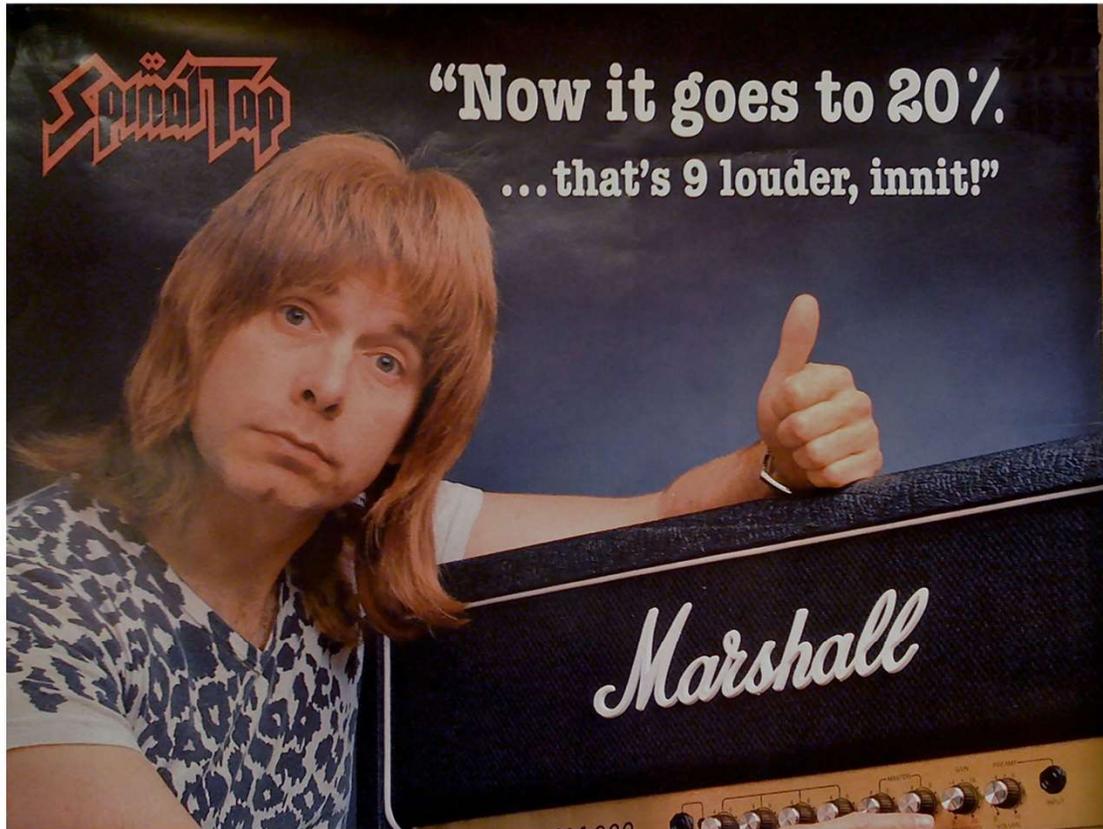
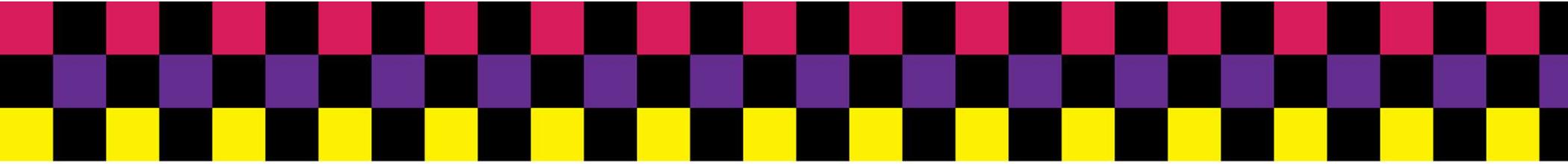
Efficiency and Reputation

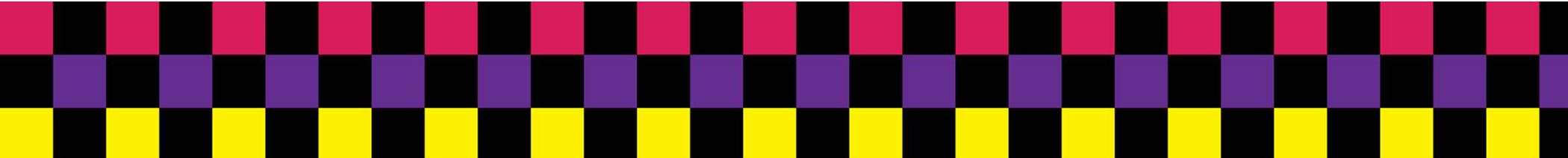
